# 49/23 Cemetery extension update / Water Butt / Advertising / Cemetery Soil / Insurance status volunteer work to cemetery / petrol mower – funding available

Mark Tully has given a quote for £376 to install a water butt. Another burial and interment plot have been reserved. Councillor Stastny and his wife are happy to continue cutting the grass in the cemetery.

RESOLVED: Councillors agreed to continue advertising the cemetery in the Teesdale Mercury and The Flyer. Funding for a petrol lawnmower is available but is currently not needed. Councillors agreed to have a wild flower area in the centre of the cemetery with a budget of £100 for the materials. Councillors agreed to store excess soil from burials in the corner of the cemetery. Councillors agreed to accept the quote for the installation of the water butt. Councillors agreed to accept the offer of a 2 seater bench for the cemetery, from a resident. Clerk to get quotes for cemetery software.
